Administrative Update

Training Updates

Tom Lockridge provided an update on training team on behalf of Susan. Tom reported that the Kentucky Prosecutors Conference had an ambitious schedule that came off very smoothly, thanks to Chad Coleman's production/engineering skills.

TSRP Updates

Tom reported the Traffic Safety Resource Prosecutor Program (TSRP) hosted the Kentucky Impaired Driving Summit on September 8th, where there was an audience of 125 police (85) and prosecutors (40). The reviews were excellent for the whole program.

On September 21-22 the TSRP presented the Basic Trial Ad for DUI training in Newport. That program was co-hosted with Ohio and 25 prosecutors were trained.

On September 23, Tom and Aaron Ann Cole addressed the District Court Judicial College on Commercial Driver's License (CDL) enforcement issues. Tom Lockridge and Susan Blake attended the NDAA Career Prosecutors Course in Louisville the first week of October. Susan plans to bring several speakers from that program to our KPC in August 2022.

The TSRP hosted the first CDL/McCarthy regional training in Henderson on October 15 and will be hosting the next session on November 3rd in Lexington. Tom reported that more than 50 are registered to attend the Lexington event and he invited the Commonwealth Attorneys to attend that session.

The County Attorney Kentucky Prosecutors Institute (KPI)is scheduled for November 15-18 in Lexington and the course is full. Next, Tom announced that the Prosecuting the Drugged Driver training will be February 23-24 at the Origin Hotel in Lexington.

Finally, it was announced that the Advanced KPI Jury Selection Training will be April 25-28, 2022. The training branch has also offered to video any prosecutor that wants feedback on their Opening Statement or Closing Argument. Interested prosecutors should contact Tom or Susan to schedule the taping.

Budget

FY2022 Update

Gina reported the 1st Quarter of FY 2022 budget has ended and things are running as anticipated.

Gina discussed the additional responsibilities that have been added to PAC staff who are already stretched thin. Specifically, HB8 Subsidy reimbursements resulted in an increase of approximately 360 payments annually. There are 20 new VOCA grants in addition to the 40 continuation grants that are currently being set up and closed according to the federal fiscal year requirements. Due to the increased number of

grants awarded, a federal fund appropriation increase in the amount of \$950,000 for Commonwealths Attorneys was submitted to the Governor's Office for Policy and Management (GOPM) and an additional \$1.1M for County Attorneys. In addition to the federal grants, PAC staff administer approximately 35 local grants and manages 900 accounts per year for over 160 employees who have split salaries.

Due to the significant increase to the Federal Fund appropriation and associated duties, Gina made a motion to utilize indirect funding to increase Diane Marcus' salary to \$30,000 through June 30, 2022. Chris Cohron motioned to approve Gina's request, seconded by Martin Hatfield and passed by voice vote.

2022-2024 Biennial Budget

Gina reported the Biennial Budget is due November 1, 2022 and compensation levels will be added to the request. As well as funding to replace SB192 (Heroin legislation) for the Rocket Docket Program.
