ORDER

This matter having come before the Court on the Attorney General's Motion for Judgment, and the Court being otherwise sufficiently advised, IT IS HEREBY ORDERED that:

1. Respondent, Your Hometown Heroes, Inc., continues to be in contempt of this Court's July 24, 2024, Order requiring it to fully comply with and respond to the Attorney General's civil investigative demand and subpoena dated February 21, 2024 (the CID and Subpoena).
2. The Order of this Court entered in this case on December 11, 2024, levying fines on the Respondent for each day it failed to comply with the Office of the Attorney General's CID and Subpoena, has not been complied with.
3. That the Attorney General had a sufficient basis for issuing the February 21, 2024, CID.
4. That as of February 5, 2026, the Respondent has not adequately complied with the aforementioned Orders of this Court and the Office of the Attorney General's CID and Subpoena.
5. That because Respondent has not adequately complied with said Order and CID and Subpoena, fines of \$1,000.00 have accrued each day since this Court entered its December 11, 2024, Order. To date, Respondent has not paid any portion of the fines levied against it by the Court in its December 11, 2024, Order.

6. That the number of days from December 11, 2024, to February 5, 2026, is 421.

7. That for all of the aforementioned reasons, Respondent is hereby found to owe \$421,000.00 in fines to the Office of the Attorney General. This monetary sanction due to Respondent's contempt is hereby converted into a monetary judgment and shall be paid to the Attorney General for the costs it has occurred as result of Respondent's contempt.
8. Respondent's corporate charter, created by or under the laws of this Commonwealth, remain vacated, annulled, or suspended pursuant to KRS 367.290(1)(b).
9. Any licenses, permits, or certificates issued to Respondent to conduct business remain revoked or suspended pursuant to KRS 367.290(1)(b).
10. Respondent is hereby permanently enjoined from engaging in any charitable activity or fundraising until it fully and completely responds to the CID to the Attorney General's satisfaction pursuant to KRS 367.290(1)(a).
11. This Order is **FINAL** and **APPEALABLE** and there is no just cause for delay.

IT IS SO ORDERED.
