## FINANCIAL INSTITUTION DATA MATCH INFORMATION

Kentucky Revised Statute (KRS) 205.712 (14) requires the Cabinet for Health and Family Services to enter into agreements with financial institutions doing business in the Commonwealth to develop and operate a financial institution data match system. Under this system, financial institutions must provide identifying information for each non-custodial parent or obligor who maintains an account at the institution, owes an arrearage, and is identified by the Cabinet.

The Financial Data Match Specifications Handbook was developed by a national work group consisting of participants from the financial industry and the child support community. Also, on the CSE website you will find a sample invoice for requesting reimbursement of the cost, up to \$250 per quarter, for the data match.
